SUMMARY

The Station Manager Intern position is responsible for assisting in the overall operation of the KOKO FM low-power radio station, including: technical functioning of the broadcast, Internet stream and Emergency Alert System; programming content including music rotation, PSAs, and other cultural and community programming consistent with the station's mission; promotion and community relations; and special events.

ESSENTIAL DUTIES AND RESPONSIBILITIES

- Ensure that the station is continuously broadcasting locally via 96.3 FM.
- Ensure that the Internet stream is continuously operational via the Yes Streaming platform.
- Ensure that the Emergency Alert System is operational.
- Curate the musical playlist and schedule, including specific time- and date-based features; add new music.
- Become familiar with the Megaseg and Audio Hijack software, and maintain the computer that runs the station.
- Become familiar with, maintain and upgrade as needed the essential station hardware and connections.
- Keep the station studio clean and well-organized.
- Research and pursue funding opportunities to develop support for ongoing, long-term job position stability.

NONESSENTIAL DUTIES AND RESPONSIBILITIES

- Maintain an inventory of station equipment and hardware.
- Coordinate with community nonprofit organizations to produce and schedule PSAs.
- Conduct outreach to community members to encourage and coordinate involvement with station programming, such as live shows, curated playlists, talk story or interviews, local news programs, calendar of events, live events, Hawaiian language programming, etc.
- Interface with school and youth programs to encourage educational uses of the station and youth involvement, especially around Hawaiian language programming.
- Communicate with supportive mentors in the community or at other stations to learn and bring in relevant expertise.
- Perform other related tasks as needed under the direction of the Supervisor
